Management Discussion of Fund Performance

Investment Objective and Strategies

The Fund seeks to provide investors with long-term capital appreciation by investing primarily in equity securities of individual companies, as well as exchange trade funds, listed on securities exchanges in North America.

The Fund will invest in the sectors or industry groups that represent attractive quantitative, fundamental and technical characteristics relative to the broad North American equities markets. As part of this tactical investment strategy, the Fund may, in certain economic and market environments, undergo relatively quick shifts in industry and sector allocations, as well as overall asset allocation. In addition, the Fund may, on occasion, partially or completely exit individual equities, and the stock market in general, in favour of cash and/or short-term money market securities.

Risk

The Fund is suitable for investors seeking income and long-term capital appreciation with a tolerance for medium risk. General risks of an investment in the Fund are detailed in the Simplified Prospectus and include capital gain risk, concentration risk, market risk, currency risk, derivatives risk, foreign investment risk, class risk, interest rate risk, large transaction risk, among others.

There were no significant changes to the investment objectives and strategies that affected the Fund’s overall level of risk during the reporting period. The risks of investing in the Fund and the suitability of the Fund for particular investor’s remains as discussed in the Simplified Prospectus.

Results of Operations

The Fund commenced operations in March 2016. During the year ended December 31, 2017, the Fund issued 11,014 Series A shares and 73,904 Series F shares, and redeemed 9,017 Series A shares and 82,285 Series F shares. As at December 31, 2017, 198,791 Series A shares, 584,115 Series F shares and 245,657 Series I shares were outstanding. During the year ended December 31, 2017, the Fund realized an accounting gain of \$412,155 from the disposition of securities.

For the year ended, the Fund earned dividend income of \$128,000. Total expenses were \$393,000 comprised mainly of \$181,000 in management fees (calculated daily at an annual rate of 2.5% of the NAV of Series A shares, 1.5% of the NAV of Series F shares and 0.75% of the NAV of Series I shares), \$50,000 in shareholder recordkeeping and fund accounting fees, \$47,000 in audit fees, \$31,000 in transaction cost, \$25,000 in filing fees and \$16,000 in custodial fees.

Net realized gains are \$412,155 for the year ended December 31, 2017 and net realized losses are \$313,551 for the year ended December 31, 2016. Unrealized appreciation of investments was \$625,634 and \$1,088,797 for the year ended December 31, 2017 and 2016 respectively.

At December 31, 2017, net assets attributable to holders of redeemable shares for Series A shares was \$2,211,751 or \$11.13 per share, for Series F shares was \$6,618,576 or \$11.33 per share and for Series I shares was \$2,819,900 or \$11.48 per share.

Recent Developments

The fund continues to be invested primarily in growth oriented stocks. Stocks trending higher, strong earning, strong relative strength and earning revision higher are favoured. A small component of high dividend, large cap stocks are present in the fund to offset style risk.

Positive corporate earnings back drop, tax cuts in the U.S., and a still favourable interest rate environment all provide a positive environment for stocks, especially growth stocks. Repatriation of overseas profits for many US companies are also injecting money into the economy providing another positive for equity markets.

The US dollar has been a head wind in the fund for the last year. A -6.8% drop in the USD/CAD pair adversely affected the fund as the portfolio is un-hedged with its currency exposure. Currently, the fund is 81% exposed to the US dollar.

There are no large changes to the strategic positioning of the fund.

Related Party Transactions

Pursuant to the amended and restated master management agreement, the Manager is entitled to an annual management fee of 2.5% of the net asset value of Series A shares, 1.5% of the net asset value of Series F shares and 0.75% of the net assets value of Series I of the Fund, calculated daily and payable monthly in arrears. For the year ended December 31, 2017, the Fund incurred \$180,901 in management fees of which \$15,980 was payable at December 31, 2017.

In order for the Fund to maintain a competitive position with other mutual funds with respect to operating expenses charged to the Fund, AlphaDelta Management Corp. (“AlphaDelta”), an affiliate of Qwest Investment Fund Management Ltd. (the “Manager”), has agreed at its discretion to pay for some of the operating expenses of the Fund. AlphaDelta has absorbed a total of \$5,947 of the operating expenses of the Fund for the year ended December 31, 2017.



Past Performance



